#### **Care and Maintenance Fees for the Cemetery and Monuments:**

A Care and Maintenance Fund is a trust fund that helps ensure the long-term upkeep of a cemetery. The Cemetery needs to make contributions to the fund from the sale of in-ground graves, niches, and scattering rights.

Ontario Regulation 30/11 under the [Funeral, Burial and Cremation Services Act, 2002](#) (FBCSA) outlines how much you need to contribute from the sale of each of these items. This will be either a percentage of the item's price (for example, 40% of the price) or a set dollar amount – whichever is greater.

Here are the contribution amounts set by the FBCSA:

- From the sale price of an in-ground grave that is 24 square feet or larger, you need to contribute either 40% of its price or \$290 – whichever is greater.
- From the sale price of an in-ground grave that is smaller than 24 square feet you need to contribute either 40% of its price or \$175 – whichever is greater.
- From the sale price of a niche, you need to contribute either 15% of its price or \$165 – whichever is greater.
- After the sale of scattering rights in a scattering ground where there is more than one scattering rights holder, you need to contribute either 15% of its price or \$30 – whichever is greater.

**Interment of Casket Burial costs:** Arrangements for the opening and closing of the grave will be the responsibility of the Funeral Home. Cost charged to the Estate.
